

The quotations should reach this office by or before 20.09.2017 14.00 hours. The sample of above items shall remain available with the Central Store Fire and Emergency Services, Batamaloo Srinagar. on any working day from 11.09.2017 to 20.09.2017.

**Terms and conditions:**

1. The quotation must be submitted in properly sealed envelope.
2. The quotationer shall sign the offer on each page.
3. The supply shall be F.O.R Central Store
4. The rates shall be quoted inclusive of all the taxes levies, and duties, freight etc.
5. Copy of Dealership/Registration certificate should be enclosed to the quotation.
6. The rates quoted should be written legible without any cuttings over writings, interpolations and erasures and in case any of these is found the quotation shall not be entertained.
7. The quotation shall be opened on 21.09.2017 or on any subsequent convenient date.
8. Supply of goods as per the sample shall be delivered in the central stores of Fire and Emergency Services, Batamaloo, Srinagar, in perfect condition within seven (7) days from the date of issue of supply order.
9. Payment shall be made by the purchasing officer after the supplies are received, inspected and accepted and properly brought on stock. No advance payment shall be made.
10. The successful tenderer who fails to supply the goods of the prescribed specification or fails to deliver the goods within the stipulated time as specifically mentioned in the supply order, the department shall be at liberty to arrange supplies by re-tendering or otherwise and the extra cost which the department may incur in such process shall be made good from the defaulting agency. The period of delivery and validity can, however, be extended, if mutually agreed to within the currency of the contract, provided sufficient reasons/ justifications are given by the supplier in such individual cases.

11. Supply of goods shall not be entertained in case it is not found as per the specifications of the supply order the goods shall be rejected and the department shall be liable to pay any charges. shall not be successful supplier who fails to supply the goods of the prescribed specification or fails to deliver the material within the stipulated time as specifically mentioned in the supply order.
